



**New treaty's entry into force set to curtail global mercury crisis, say NGOs**

**BRUSSELS - 16 AUGUST 2017**

**TODAY'S ENTRY INTO FORCE OF THE MINAMATA CONVENTION ESTABLISHES THE FIRST NEW**

“While there are alternatives to mercury, there are no alternatives to global cooperation,” said Michael B  
“Only a global pact can curtail this dangerous neurotoxin.”

In October 2013 the convention text was adopted and signed by 128 countries, but would not take legal
